

Navigating a Pandemic with Thematic ETFs

During the first half of 2020, 13 thematic First Trust ETFs outperformed the S&P 500 index, which posted a total return of -3.1%. Ten of these ETFs had positive year-to-date returns (see chart 1). Many of these outperformers operate in industries less impacted—if not bolstered—by the COVID-19 pandemic and aggressive government response. For example, Internet (FDN and FDNI), Cloud Computing (SKYY), Biotechnology (FBT), and Cybersecurity (CIBR) have all been beneficiaries of the pandemic as their products and services have become integral in coping with the virus as well as helping companies and their employees remain productive while sheltering in place at home.

On the other hand, 15 thematic First Trust ETFs underperformed the S&P 500 during the first half of 2020. Many of the worst performing ETFs were focused on economically sensitive areas, such as Banks (FTXO and QABA), Energy (FCG and FTXN), and Transportation (FTXR).


Chart 1: First Trust Thematic/Industry ETFs (Year-to-Date Total Returns, as of 6/30/20)



Thematic ETFs that Won by Losing Less

Several of the thematic ETFs that outperformed during the first half of 2020 did so by losing less on days that the S&P 500 index posted negative returns. Among the 13 outperformers, 9 had less downside capture than the S&P 500 (see chart 2). The outliers that outperformed despite having higher downside capture ratios were Semiconductors (FTXL), equal-weighted Technology (QTEC), Smart Grid Infrastructure (GRID), and Green Energy (QCLN).



and still have the worst year-to-date returns, including Banks (FTXO and QABA) and Energy (FTXN and FCG).

High Upside Capture Did Not Always Lead to Outperformance




While 13 thematic First Trust ETFs outperformed on days that the S&P 500 Index was positive, only 6 of these outperformed during the first half of 2020 (see chart 3). In fact, many ETFs with the highest upside capture ratios were focused on themes or industries that were hit hardest by the pandemic,

Highest Net Capture Ratios for Thematic ETFs

During the first half of 2020, there were 13 ETFs that had positive net capture ratios, meaning each had a higher upside capture ratio than its downside capture ratio. Naturally, these were the same 13 ETFs that outperformed the S&P 500 during that period (see chart 4).

Implications for the Months Ahead—Positioning for Upside or Downside Scenarios with Thematic ETFs

Predicting the future is much more difficult than reviewing the past. This is especially true amid an unprecedented global pandemic and a variety of aggressive government responses. However, if the trends established during the first half of 2020 continue in the months ahead, we believe thematic ETFs may be useful tools in positioning portfolios. Under more optimistic scenarios, we believe economically sensitive ETFs with higher upside capture ratios, such as Banks (FTXO and QABA) and Energy (FTXN and FCG), are likely to outperform. Under more pessimistic scenarios, themes with the lowest downside capture ratios may help to limit losses. But we believe the sweet spot between optimism and pessimism may be found in ETFs with relatively low downside capture ratios, and positive net capture ratios. First Trust thematic ETFs with downside capture ratios under 85% and positive net capture ratios (year-to-date) include: FDNI, SKYY, FDN, FBT, CIBR, NXTG, FAN, and FTXH.
